This is part of the vetting process for candidates for election.</i><i>Under Appendix II of the BWF Constitution, there will be a vetting process undertaken in order to determine my eligibility, against the criteria in Clauses 2.4.1 to 2.4.8 of Appendix II, to be a candidate for the elections to Council.</i><ul style="list-style-type: none"><i>The vetting process involves an external company conducting background checks related to the criteria in Clauses 2.4.1 to 2.4.8.</i><i>The vetting company will provide a report to the Vetting Panel made up of three independent and external experts.</i><i>The Vetting Panel will consider all information as private and confidential. However, the candidate’s name, nationality and languages, together with the answers to sections a. to e. of this Form B, will be shared with the BWF membership as part of the elections process.</i><i>The Vetting Panel uses this Form B, the Candidate’s Declaration Form (available in late January 2021), the report from the external company and the criteria in Appendix II (Clauses 2.4.1 to 2.4.8) to determine my eligibility as a candidate for election to the BWF Council.</i><i>The role of the Vetting Panel is to declare candidate eligible or ineligible.</i><i>If the Vetting Panel declares me ineligible, I have a right of appeal.</i><i>The enclosed information about my qualifications and experience may be used in the candidate profiles distributed to the membership in early April with the AGM papers.</i>
