4. **Draws**

In accordance with BWF World Tour Regulations, the following draw sizes will be implemented in Men's Singles, Women's Singles, Men's Doubles, Women's Doubles and Mixed Doubles:

- Qualification Draw: There will be no Qualifying Draw in any event.
- Main Draw: 32 players/pairs in each Main Draw event (no qualifying positions).

All events will be run on a strict timetable system, and any changes to the schedule of play will be announced by the Referee. Competitors should be ready to play at least 15 minutes prior to their scheduled time, and failure to arrive on court at this time will result in the player/pair being disqualified.
