Entry:

All entries must be made by using the BWF Online Entry System. Entries must be submitted no later than Tuesday 30 January 2018 at 23.59 BWF HQ time (GMT +08.00).

No late entries will be accepted.

Players cannot be entered unless they already have a BWF ID-number. In case you wish to enter players who do not have a BWF ID-number, please contact the BWF office well in advance of the tournament, so that the players concerned can get a BWF ID-number before the closing date of the tournament.

The Member Association that enters a player into a Circuit tournament is responsible for paying the entry fees for that player. The entry fees become due if a player is entered and has not been withdrawn by the Member Association by midnight local time on the closing date. It is recommended that the entry fees are paid by bank transfer, but the organizers can accept cash payment at tournaments.

The entry fees will not be refunded in the case of a withdrawal. For all the withdrawn players the organizers can invoice the entry fee to the relevant member Association. This must be done by registered mail. The invoice must have a deadline for the payment and the information that if no payment has been received after the deadline has passed the organizers will forward the invoice with the registration of deliverance and the copy of the original entry together with the original invoice to BADMINTON EUROPE.

All this must be done within 2 (two) months after the end of the tournament. If a player/pair is listed on a "Waiting List", no entry fee is to be paid before being promoted to the Main Draw or Qualification draw. Before such a promotion takes place, the organizers must have this promotion confirmed by the respective player(s) federation(s). Only when this confirmation has been given, the player(s) is/are considered as an entry.

Organizers are allowed to refuse entries if players have outstanding fees from a previous year. All entries must be confirmed by the National Association.

The organizer must acknowledge all entries.

Conditions:

- the tournament will be run strictly in accordance with the Competition Regulations of the BWF and the Regulations for Badminton Europe Circuit
- the tournament will be played on a knock-out system
- in the events of any dispute, the Referee's decision shall be final,
- no player shall be eligible to compete unless he/she is in good standing with his/her National Association.

Withdrawals:

Any withdrawal after the Monday immediately preceding the draw, for any reason whatsoever, renders the Member Association concerned liable to an amount of US\$ 150,00 for the inconvenience caused by the withdrawal (as defined in BWF General Competition Regulations).

Any player not showing up at the tournament, without having been withdrawn in advance, renders the Member Association concerned liable to an additional amount of US\$ 500,00 for the inconvenience caused by the "no show" (as defined in BWF General Competition Regulations).

Visa:

If you need a visa to travel to Slovakia, please contact the organisers no later than 1 February 2018.

Departure:

Players shall not plan their departure less than two (2) hours after their last match is planned to conclude. If a player/pair is unable to compete due to early departure, such a player/pair shall lose all the Circuit Ranking points gained at the particular tournament and BADMINTON EUROPE shall propose to BWF that the gained BWF ranking points are also removed.

Clothing/ Advertising:

In accordance with BWF's Regulations 19-23 and BE Circuit Regulations 18.2 and 18.3.

Insurance:

To be arranged by individual participants.

Drug testing:

According to Slovakian law Drug Testing may be carried out on a random basis at any time.

Betting:

Betting might be offered from this event. Please note that betting is not allowed to be made by players or officials connected to the Event either in person or through a third party. Participants may therefore not make bets on the Event or procure through third parties the making of bets with a betting agency. Participants who, in violation of this prohibition, nevertheless make or procure through third parties the making of bets with betting agencies shall be immediately disqualified from participation in the Event and are liable for legal prosecution. Similarly manipulation of games will be met with disqualification and possible legal prosecution. Any violation mentioned above is also a breach of Player's Code of Conduct (Art. 5.2.) and will be sanctioned by BWF.
