- Main Draw: 32 players/pairs in each Main Draw event (no qualifying positions)

All events will be run on a strict timetable system, and any changes to the schedule of play will be announced by the Referee. Withdrawals of players will be handled as per BWF General Competition Regulations and Player Commitment Regulations.

Photography is not permitted within the playing arena at any time, and the Championships reserves the right to remove any items of equipment breaching this policy.

Video recording within the playing arena is only permitted by players and Team Officials of competing Member Associations from clearly defined points using video accreditation passes.

There are a limited number of these positions and passes available, and prior authorisation must be obtained in advance from the Information Office, and accreditation must be clearly displayed on the cameras. The Championships reserves the right to remove any non-accredited items of equipment.
