Regulation 2.3 of the Junior Circuit Regulations:

It is required that every event in a particular BEC Junior Circuit tournament has at least 8 competitors (i.e. actual competitors, not merely entries). If the required number of competitors is not met, this particular event shall not count towards any ranking.

In accordance with regulation § 9.4 in BWF Statutes, Section 5.3.3.2: World Junior Ranking System, an event must contain at least one entry from a Member Association other than the hosting Association. If an event does not contain at least one entry from a Member Association other than the hosting Association, this particular event shall not count towards any ranking.

BADMINTON EUROPE is not liable for any costs incurred by third persons (players, coaches, umpires, team managers etc.) because of an event not having enough competitors to count for the rankings.

## Tournament Regulations

All matches will be played on 6 approved Badminton Court Mats according to a fixed schedule. The knock-out system will be used. Rejections and the schedule for the tournament will be published successively, together with the draw by Badminton Europe (BE) / the Badminton World Federation (BWF).

All players should be ready to play 30 minutes before their scheduled match.

Changes in the draw and schedule are possible. They will be posted as early as possible and affected players will also be informed in time.

## Entry Fees

Singles 35,00 € | Double/Mixed 25,00 € per player

According to BEC Junior Circuit Regulation 12.1 :

The Member Association that enters a player/pair into a BEC Junior Circuit tournament is responsible for paying the entry fees for that player/pair. The entry fees become due if a player is entered and has not been withdrawn when the entry deadline passes.

General Request Forms and hotel reservations will be processed in the order received.

Changes or modifications may be made until 20<sup>th</sup> of September 2019 without penalties. After the 21<sup>th</sup> of September 2019 you are obligated to pay a 100% cancellation fee for the entire booking.

We or the hotel will attempt to resell your room reservation to someone else, which could result in a refund.

Bookings received after 20<sup>th</sup> of September 2019 will only be honoured based on availability and will be charged a late booking fee of 10 € per person and room.

### **Liability in the Hotels**

In Germany, it is forbidden to cook in all hotels as this presents a fire hazard!

All misconduct will automatically result in costs and be charged to the team/association concerned!

The organizer assumes no liability for any damages to hotels or the venue.

### **Payment**

### **Clothing & Advertising Regulations**

---

Colour, design, lettering and advertising on clothing shall be regulated by BWF Statutes, Section 5.2.3: Junior Tournament Regulations § 12 to 16. A player violating these regulations shall be penalised by an administrative fine of 50,00 EUR.

It is mandatory for the semi-finals and finals that partners in doubles wear the same colour of the T-shirt and shorts/skirts. Failing to do so shall result in an administrative fine of 50,00 EUR.

The decision of the referee is final.

### **Presentation Ceremonies**

---

Players are not allowed to wear hats or caps during the presentation ceremonies. Rackets may not be carried during presentations. Tracksuits, or clothing as worn during play, will be allowed. No other form of advertising will be permitted. This regulation will be strictly enforced by our stewards prior to each ceremony.

Athletes are responsible for any substance found in their body. Before an athlete takes any medication, they should check with their doctor, and if necessary, get a Therapeutic Use Exemption (TUE).

### **Badminton Integrity**

---

Section 2.4 of the BWF Statutes (Code of Conduct in Relation to Betting, Wagering and Irregular Match Results) relates to anti-corruption and anti-match manipulation, and this code applies to all participants at this tournament.



To protect the integrity of BWF sanctioned tournaments, participants are not allowed to bet in any way on badminton matches, respect the principle of fair play, and shall not attempt to influence the course or result of a game or match.

Every person has an obligation to report to the BWF any approaches by anyone to gather inside information or to change the outcome of a matches.
