ENTRY FEES

If entry fee is not paid according to the regulations, the players concerned are not allowed to play. The member association that enters a player into a circuit tournament is responsible for paying the entry fees for that player.

WITHDRAWALS

Please ensure that the organizers are informed immediately when a player has to withdraw, together with the reason. Attention: Any withdrawal after the Sunday immediately preceding the draw, for any reason whatsoever, renders the Member Association concerned liable to an amount of \$150,00 for the inconvenience caused by the withdrawal (as defined in BWF General Competition Regulations). **Final Date to withdrawals without penalty is Monday, March 30th, 2020 until 23:59h** BWF HQ (GMT +08:00h) Kuala Lumpur – Malaysia.

VISA

For all player and officials, who require visa to enter Peru, should submit full passport details (Full name, Passport No, and Date of Issue & Expiry contact no.) to badmintonperu@gmail.com later than March 3rd, 2020

UNIFORMS

According to BPAC regulations, for all tournaments that are part of the Pan American Circuit **the player's name and the country name or code on the back of the shirt is mandatory.** (BWF GCR, referring player's clothing, designs, advertising and lettering)

TRANSPORTATION

The organization will offer transportation from the airport to the official Hotel, and the venue, **only when booking for the Official Hotels.** Bus schedule will be set up according to competition schedule

MEDICAL SERVICES

A doctor and a physiotherapist will be at the venue while matches are on.

Athletes are responsible for any substance found in their body. Before an athlete takes any medication, they should check with their doctor, and if necessary, get a Therapeutic Use Exemption (TUE).

BADMINTON INTEGRITY

Section 2.4 of the BWF Statutes (Code of Conduct in Relation to Betting, Wagering and Irregular Match Results) relates to anti-corruption and anti-match manipulation, and this code applies to all participants at this tournament.

To protect the integrity of BWF sanctioned tournaments, participants are not allowed to bet in any way on badminton matches, respect the principle of fair play, and shall not attempt to influence the course or result of a game or match.

Every person has an obligation to report to the BWF any approaches by anyone to gather inside information or to change the outcome of a matches.
