Uniforms:

According BPAC regulations, for all tournaments that are part of the Pan American Circuit **the player's name and the country name or code on the back of the shirt is mandatory.** (BWF GCR, referring player's clothing, designs, advertising and lettering)

Transportation:

Fairfield by Marriott, San Salvador: will offer transportation from the airport to the hotel only when booking for the Official Hotel.

FESALBAD: will offer transportation from the hotel to the venue, only when booking for the Official Hotel.

Bus schedule will be set up according to competition schedule.

Medical service:

Doping Control:

Doping control in badminton, in accordance with BWF AntiDoping Regulations, is conducted out-of-competition and in-competition with the collection of urine and/or blood samples. Athletes are responsible for any substance found in their body. Before an athlete takes any medication, they should check with their doctor, and if necessary, get a Therapeutic Use Exemption (TUE).
