## ENTRY FEES

**Cost:** \$ 200,00 per player

Paid in cash before beginning of tournament. Credit or debit card payments shall be requested at least 3 days prior to the tournament tip-off and will have a 5% surcharge.

If entry fee is not paid according to the regulations, the players concerned are not allowed to play. The member association that enters a player into a circuit tournament is responsible for paying the entry fees for that player.

## WITHDRAWALS

Please ensure that the organizers are informed immediately when a player has to withdraw, together with the reason. Attention: Any withdrawal after the Sunday immediately preceding the draw, for any reason whatsoever, renders the Member Association concerned liable to an amount of \$150,00 for the inconvenience caused by the withdrawal (as defined in BWF General Competition Regulations). **Final Date to withdrawals without penalty is Monday October 31<sup>st</sup>, 2022;** until 23:59h BWF HQ (GMT +08:00h) Kuala Lumpur – Malaysia.

## VISA

## UNIFORMS

According to BPAC regulations, for all tournaments that are part of the Pan American Circuit **the player's name and the country name or code on the back of the shirt is mandatory.** (BWF GCR, referring player's clothing, designs, advertising and lettering)

## TRANSPORTATION

The organization will offer transportation from the airport to the official Hotel, and the venue, **only when booking for the Official Hotels through the Local Organizing Committee.** Bus schedule will be set up according to competition schedule

## MEDICAL SERVICES

A doctor and a physiotherapist will be at the venue while matches are on.

## MEDICAL INSURANCE

## COVID-19 CONSIDERATIONS

The local organizing committee (LOC) initially can offer one single accommodation option at Villa Deportiva Nacional (VIDENA), due to restrictions imposed by the regulations established by the National Sports Institute and the Peruvian Government. The LOC can suggest other accommodation options nearby the venue upon request; however, any participant not staying at the official hotel shall comply to greater restrictions within the venue, in order to guarantee everybody's safety, to be established by the LOC during the competition period. Protocols are to be published separately.

## Anti - Doping:

Anti-doping will be conducted in accordance with BWF and WADA regulations. Please consult the BWF website for further information, and to view the current WADA Prohibited List. Please note that athletes must complete a TUE application process to apply for authorization to take medications which fall under the Prohibited List – before they take medication.

## Doping Control:

Doping control in badminton, in accordance with BWF Anti-Doping Regulations, is conducted out-of-competition and in-competition with the collection of urine and/or blood samples.

Athletes are responsible for any substance found in their body. Before an athlete takes any medication, they should check with their doctor, and if necessary, get a Therapeutic Use Exemption (TUE).

## Badminton Integrity

Section 2.4 of the BWF Statutes (Code of Conduct in Relation to Anti-doping will be conducted in accordance with BWF and WADA regulations. Please consult the BWF website for further information, and to view the current WADA Prohibited List.

Please note that athletes must complete a TUE application process to apply for authorization to take medications which fall under the Prohibited List – before they take medication.

Betting, Wagering and Irregular Match Results) relates to anti-corruption and anti-match manipulation, and this code applies to all participants at this tournament.

To protect the integrity of BWF sanctioned tournaments, participants are not allowed to bet in any way on badminton matches, respect the principle of fair play, and shall not attempt to influence the course or result of a game or match.

Every person has an obligation to report to the BWF any approaches by anyone to gather inside information or to change the outcome of a matches.
