## Uniforms:

According BPAC regulations, for all tournaments that are part of the Pan American Circuit **the player's name and the country name or code on the back of the shirt is mandatory**. (BWF GCR, referring player's clothing, designs, advertising and lettering)

Athletes are responsible for any substance found in their body. Before an athlete takes any medication, they should check with their doctor, and if necessary, get a Therapeutic Use Exemption (TUE).
